

**RELEASE**

In consideration of the undersigned and/or his or her minor child entering upon certain real property (the "Property") belonging to Anne and Michael Moran, E. Eugene Weymouth and Whitehackle Company (collectively, the "Owners") and/or the undersigned or his minor child being invited or permitted to participate in the Pennsylvania Pony Hunt Cup organized by Anne and Michael Moran and the Pennsylvania Hunt Cup Committee for the benefit of the Chester County Food Bank, Inc. (the "Beneficiary"; each of the Owners, the Pennsylvania Hunt Cup Committee, the Beneficiary and its respective successors, assigns, personal representatives, heirs, agents, directors, officers, trustees and employees being individually referred to herein as an "Indemnatee"), the undersigned does hereby expressly, unconditionally and voluntarily (i) agree that neither the undersigned nor any of his/her successors, assigns, personal representatives, executors, dependents or heirs (collectively, the "Undersigned") shall make any claim ("Claim") of any type whatsoever against any Indemnatee arising out of or relating to any action or inaction by any Indemnatee or any accident, injury or event which takes place on or in the vicinity of the Property or is related to the Pennsylvania Pony Hunt Cup, (ii) agree that no Indemnatee shall be required to make any payment or provide any benefit whatsoever to the Undersigned in connection with any Claim or liability relating thereto, (iii) hold harmless, release, remise and forever discharge each Indemnatee from all Claims and all liabilities relating thereto, including without limitation, all possible claims, issues and causes of action, whether known or unknown, and of whatever kind or nature, which the Undersigned now has or may hereafter acquire in any capacity which arise out of or relate to any contract, tort, duty, law, statute, regulation or any other basis whatsoever, (iv) indemnify each Indemnatee for, and hold each Indemnatee harmless against, all Claims and all liabilities relating thereto, (v) agree that all liabilities, costs and expenses relating to any Claim or liability thereto shall be the sole responsibility of the Undersigned, and (vi) agree that his/her execution of this Release binds him/her and each of his/her successors, assigns, personal representatives, executors, dependents and heirs.

I also agree to hold harmless volunteers and employees of the PA Hunt Cup including but not limited to Regina Welsh, Molly Greene, U.S. Pony Racing, LLC, Sanna Neilson, and outriders assisting on the day. I approve the use of photos taken on the day of my entry to be used for marketing and advertising purposes.

My entry will use safety stirrups, a yoke (or neck strap), overgirth, protective vest, approved helmet, and has a current health insurance policy. I also verify that the rider listed on this release has not had their 16<sup>th</sup> birthday as of January 1<sup>st</sup> of the current year.

**THE UNDERSIGNED ACKNOWLEDGES AND AGREES THAT (1) EVENTS SUCH AS THE PENNSYLVANIA PONY HUNT CUP ARE INHERENTLY DANGEROUS AND POSE A SERIOUS RISK OF SEVERE INJURY INCLUDING BUT NOT LIMITED TO DISABILITY OR DEATH, (2) HE/SHE HAS CAREFULLY READ AND UNDERSTANDS THIS RELEASE, AND (3) HE/SHE IS ENTERING INTO THIS RELEASE WITH THE FULL KNOWLEDGE THAT HE/SHE IS THEREBY FOREVER WAIVING ALL LEGAL RIGHTS OF THE UNDERSIGNED TO SEEK ANY LEGAL DAMAGES OR OTHER REDRESS FOR INJURIES TO THE UNDERSIGNED OR TO HIS OR HER MINOR CHILD AGAINST ANY INDEMNITEE FOR ANY CLAIM OR LIABILITY WITH RESPECT TO THE PARTICIPATION BY THE UNDERSIGNED OR HIS OR HER MINOR CHILD IN THE PEOPLECHASE.**
